## U Care Back to School Vouchers 2010

#### 1 ELIGIBILITY CRITERIA

To be eligible for the \$125 worth of Back to School Vouchers, the union member must meet all of the following criteria:

- i. Total gross monthly household income of **S\$1,800** and below; OR per capita income of **S\$500** and below per month;
- ii. Has minimum 6 months continuous paid-up union membership;
- iii. Member's child/children must be studying in Kindergarten 1 or 2; Government/Government-Aided Schools (Primary or Secondary) under MOE; Junior Colleges; Institute of Technical Education; Polytechnics; Millennia Institute or MOE-registered Special Schools.

**Please note: Graduating students** (e.g. final year college/poly students) who will not be attending schools as stated above in Year 2011 **will not** be eligible for the Back to School Vouchers.
